A profile of youth corrections involvement

Child and Youth Data Laboratory (CYDL) Longitudinal Project

Introduction

This report is an overview of the experiences of young Albertans (12 to 25 years) with youth corrections involvement from 2005/06 to 2010/11. Individuals with corrections involvement may have appeared before the Court or a Justice of the Peace for an offence and have been remanded in custody or placed under pre-trial supervision in the community awaiting further court dates. Otherwise youth have been found guilty and sentenced to a community disposition (i.e. fine, probation, community service work) and/or custody (in which the sentence is served in a young offender facility).

Court outcome was grouped into extrajudicial sanctions (program to withdraw the offence record if completed), not sentenced (offence record removed), remand (custody while awaiting trial), custodial sentence (e.g. correctional facility), non-supervised (fines, reprimands, prohibition, etc.), and supervised (probation, conditional supervision, community supervision, conditional discharge, pretrial supervision, etc.).

Key Findings

- 1% of youth and young adults had youth corrections involvement in a given year (range 7,027 to 9,682).
- A higher proportion of individuals with youth corrections were male, lived in the lowest socio-economic status neighbourhoods, moved one or more times, were high cost health users, had a mental health service, were Child Support Services dependents (those whose parent receives support), received Child Intervention services, or were students with special needs as compared to those with no corrections involvement.
- Youth and young adults with corrections involvement were less likely to be meeting or above educational expectations compared to those with no corrections involvement.
- Extrajudicial sanctions and supervised community sentences were the most common court outcomes.
- A lower proportion of youth and young adults with extrajudicial sanctions were male, lived in the lowest socio-economic status neighbourhoods, were high cost health users, received a mental health service, or received Child Intervention services compared to those with other court outcomes.

Background literature

Providing a context for the current report, this section highlights select literature focusing on factors related to criminal activity in Canada.

In Canada, the Youth Criminal Justice Act governs sentencing of youth aged 12 to 17 at the time of offence¹. Individuals receiving youth corrections may be aged 18 or older due to time required to process the offence through court and the duration of corrections programs .

The province administers correctional services for youth².

Correctional involvement takes place in two general forms: custody (remand or in a custodial facility) and community (community settings)². Individuals can be "not sentenced" through extrajudicial sanctions or other means for the offence to be removed. They could be held in custody either in remand while awaiting trial or after being sentenced to custody. Community sentences are more common for youth and they can either be supervised (probation, conditional sentence, etc.) or non-supervised (fine, compensation, etc.)². Probation is typically the most common type of corrections involvement².

Youth and young adults with corrections involvement have complex service needs. They are more likely to be hospitalized or visit an emergency room and less likely to visit a physician compared to those with no corrections involvement³. Mental illness^{4,5} and Child Intervention services⁶ are more common among those involved with corrections and school performance tends to be lower among those with criminal activity⁵.

Footnotes

The data analyses in this report include provincial corrections data from Justice and Solicitor General.

- Individuals aged 12 to 25 with adult corrections involvement and no youth corrections involvement in a given study year (approximately 300 to 700 per year) were removed from analyses in this report.
- *Extrajudicial sanctions* (called alternative measures for adult corrections) are considered when the offence is not serious or repeated. The youth must accept responsibility for the offence and if the sanction is completed, the offence is withdrawn and does not result in a conviction.
- **Not sentenced** includes a number of ways in which the offence is removed including dismissed, not criminally responsible, withdrawn, loss of jurisdiction, etc.
- An offender is placed in *remand* to be held in custody until their court date.
- *Custodial* sentences occur in a correctional facility.
- *Non-supervised* corrections are comprised of a number of court outcomes that do not involve supervision including fines, prohibition order, compensation order, or reprimands.
- **Supervised community** corrections involve supervising and monitoring in the community and include probation, conditional supervision, community supervision, pretrial supervision, breach, and appeals, etc.


Ninety-five percent confidence intervals were calculated to enable comparison of statistical differences between groups. The Cochran-Armitage trend test was used to test trends over time. Corrections involvement (Table 1; p. 14)


This and the following analyses consider young Albertans (aged 12 to 25 unless otherwise specified). See *Definitions and Notes* for more information about the population being profiled (p. 40).

- Around 1% of young Albertans had youth corrections involvement (7,027-9,682 per year compared to 785,981-814,998 per year with no correction involvement).
- This rate varied by less than 0.3% across study years.


- Approximately 1% of individuals living across Alberta regions had youth corrections involvement.
- The percentage of corrections involvement was not consistently higher in any region across all study years.


Age group by corrections involvement (Table 3; p. 16)


Age shown is for 2010/11 (see Table 3 for age distribution in each study year). Age groups are not even due to the distribution within youth corrections.

- Youth corrections involvement peaked at ages 16 to 19.
- Very few individuals received youth corrections over the age of 20 which was expected because youth corrections are for individuals charged for offences committed between ages 12 to 17 years.

Percentage of young Albertans, by age group in 2010/11 and corrections involvement








Gender by corrections involvement (Table 4; p. 17)


- Females were less likely to have corrections involvement than males.
- 29% of individuals with youth corrections were female and 71% were male.
- There was little variation across study years.

◆Any corrections ◆No corrections


Socio-economic status (SES) captures the social and material environments in which individuals live. See *Definitions and Notes* for further clarification (p. 39).

- Individuals with youth corrections involvement were proportionally more likely to live in the lowest socio-economic status neighbourhoods and less likely to live in the highest socio-economic status neighbourhoods as compared to youth and young adults with no corrections involvement.
- 37 to 38% of youth and young adults with youth corrections lived in the lowest socio-economic status neighbourhoods compared to 23 to 25% of individuals with no corrections involvement.


Residential mobility by corrections involvement (Table 6; p. 19)

Residential mobility was determined using the number of unique postal codes in the Alberta Health registry. Residential mobility is shown in 2010/11 (see Table 6 for mobility in each study year).


- Corrections involvement was associated with a greater percentage of high-cost health service users.
- Approximately 11% of youth and young adults with youth corrections involvement were high cost health users in a given study year compared to 5% of individuals with no corrections involvement.

Mental health service use by corrections involvement (Table 8; p. 20)


Mental health service use is defined as receipt of a diagnosis from select services. See *Definitions and Notes* for more details (p. 39).

- A higher percentage of youth and young adults with corrections involvement had mental health service use in comparison to those with no corrections involvement.
- This pattern remained relatively stable over time.

Educational achievement by corrections involvement (Table 9; p. 20)

This analysis considers individuals in grades 3 to 12 who were registered in the Alberta education system. See *Definitions and Notes* (p. 39).


• 35% to 38% of individuals with youth corrections were meeting or above educational expectations compared to 81 to 83% of those with no correctional involvement.

Child Support Services – Dependents by corrections involvement (Table 10; p. 21)


This analysis includes individuals aged 12 to 24 who were dependents receiving Child Support Services (those whose parent receives support). See *Definitions and Notes* (p. 38) for more details.

• 5 to 7% of individuals with youth corrections received Child Support services as a dependent compared to 1% of those with no corrections involvement.

Child Intervention services by corrections involvement (Table 11; p. 21)


This analysis considers Albertans (aged 12 to 22 years) receiving Child Intervention services. See *Definitions and Notes* (p. 38).

- A higher percentage of individuals involved in corrections received Child Intervention services compared to those with no corrections involvement.
- There was a slight general trend of a decreased percentage of youth and young adults involved in corrections also receiving Child Intervention services over time.


Students with special needs by corrections involvement (Table 12; p. 22)

This analysis considers Albertans (aged 12 to 19 years) who were students with special needs. See *Definitions and Notes* (p. 39).

Health care registry by corrections involvement (Table 13; p. 22)


 A slightly lower proportion of individuals with youth correctional involvement were registered in the health care registry compared to those with no corrections involvement.

Court outcome- population level (Table 14; p. 23)


Corrections involvement was further broken down into court outcomes for this and the remaining graphs. See *Definitions and Notes* (p. 38) for more information on court outcomes. Youth may have one or more court outcome.

- Less than 1% of individuals had any one type of youth court outcome.
- Extrajudicial sanctions and supervised community outcomes were the most common court outcomes and these varied over time.

Court outcome (Table 14; p. 23)

This and all following analyses include only those with corrections involvement in the study year.


- Among those with youth corrections, 3,481-4,664 had extrajudicial sanctions, 2,858-5,119 had supervised community, 1,439-2,084 had non-supervised community, 692-817 were in remand, 669-734 were not sentenced, and 353-415 were in custody in any given study year.
- The percentage of individuals receiving extrajudicial sanctions decreased over time and the percentage receiving supervised community outcomes increased over time.

Age group by court outcome (Table 15a,b; p. 24-25)

Age shown is for 2010/11 (see Table 15 for age distribution in each study year). Age groups are not even due to the distribution within youth corrections.

- The peak age for most court outcomes was age 16 to 17 years.
- Almost half of individuals with supervised community outcomes were aged 18 to 25. This is consistent with the timing of these types of supervision coming later in sequence compared to other court outcomes.

Percentage of Albertans aged 12 to 25 with corrections involvement, by age group and court outcome in 2010/11




Gender by court outcome (Table 16; p. 26)

Percentage of Albertans aged 12 to 25 with youth corrections involvement, by gender and court outcome over time




- Most youth and young adults with corrections involvement were male across all court outcomes.
- Individuals with extrajudicial sanctions had the highest percentage who were female (35 to 36%).
- 14 to 28% of individuals with any of the other court outcomes were female.

Socio-economic status by court outcome (Table 17a,b; p. 27-28)



Socio-economic status (SES) captures the social and material environments in which individuals live. See *Definitions and Notes* for further clarification (p. 39).

- Youth and young adults with extrajudicial sanctions were more likely to live in the highest socio-economic status areas and less likely to live in the lowest socio-economic status areas compared to individuals with other court outcomes.
- There were no discernable patterns of SES by court outcome over time.
- There were too few individuals with custodial sentences to show highest SES in all years so data were suppressed and not shown in graph (see Table 17 for custodial sentences in available years).



Residential mobility by court outcome (Table 18a,b; p. 29-30)


Residential mobility was determined using the number of unique postal codes in the Alberta Health registry. Residential mobility is shown in 2010/11 (see Table 18 for mobility in each study year).

Residential mobility was relatively similar across court outcomes.


High cost health service use by court outcome (Table 19; p. 31)

 A lower percentage of youth and young adults with extrajudicial sanctions were high cost health users compared to most other court outcomes but were still higher than those with no corrections involvement (5%; not shown in graph; see Table 7). Mental health service use is defined as receipt of a diagnosis from select services. See *Definitions and Notes* (p. 39).


• 19 to 21% of those with extrajudicial sanctions had a mental health service. This is a lower than those with other court outcomes but higher than those with no corrections involvement (7%; not shown in graph; see Table 8).

Educational achievement by court outcome (Table 21; p. 33)


This analysis considers individuals in grades 3 to 12 who were registered in the Alberta education system. See *Definitions and Notes* (p. 39).

- Youth and young adults with extrajudicial sanctions had the highest proportion meeting or above educational expectations (44 to 48%).
- 16 to 27% of individuals with supervised community or non-supervised outcomes were meeting or above educational expectations compared to 5 to 12% of individuals with custodial sentences, in remand, or not sentenced.


• 4 to 12% of youth and young adults with youth corrections involvement were receiving Child Support Services as dependents.

Child Intervention service use by court outcome (Table 23; p. 35)


This analysis considers Albertans (aged 12 to 22 years) receiving Child Intervention services. See *Definitions and Notes* (p. 38).

- A higher proportion of young Albertans who were not sentenced, in remand or had custodial sentences received Child Intervention services compared to individuals with other court outcomes.
- The lowest percentage receiving Child Intervention services were individuals with extrajudicial sanctions.

Students with special needs by court outcome (Table 24; p. 36)

 There was little discernable difference among court outcomes.

Health care registry by court outcome (Table 25; p. 37)

 Those with extrajudicial sanctions or with supervised community sentences had the lowest proportion in the health care registry in most study years.

Percentage of Albertans aged 12 to 25 with youth corrections involvement who were in the health care registry, by court outcome over time



Definitions and notes

- Age, gender, and postal code (translated into Statistics Canada dissemination areas) were provided for
 each individual by each participating program. In the case of discrepancies between programs, the most
 common value for an indicator was chosen. In the event of two or more most common values, the value
 for the indicator was chosen randomly from the most common values.
- The **Alberta Health Care Registry** (also known as the Alberta Health Care Insurance Plan) includes all study participants (aged 0 to 30) who are eligible to receive insured hospital and physician services.
- **Child Intervention** services are focused on meeting the safety and well-being of children and helping families and communities to meet these needs. The Child Intervention Program provides services to children and youth between the ages of 0 and 17 years who are or may be at risk of being abused, neglected or otherwise in need of intervention. As well, young adults (18-22 years of age) may also be eligible for post-intervention supports through the use of Support and Financial Assistance Agreements to help them transition to adulthood.
- Children's Services (CS) and Community and Social Services (CSS) service delivery regions were used for regional analyses. Dissemination areas from the 2006 Statistics Canada Census were used to determine region. Those with missing dissemination areas are excluded from analyses. There are seven regions (Northwest, Northeast, North Central, Edmonton, Central, Calgary, South); the boundaries for these regions are shown on the map.
- **Child Support Services** helps Applicants (single parents and parents in blended families, aged 18 to 30) reach child support payment agreements or obtain court orders for payment from Respondents (aged 18 to 30), for Dependant children (aged 0 to 24).
- Youth with **corrections involvement** have appeared before the Court or a

 Justice of the Peace for an offence charge and have been remanded in custody or
 placed under pre-trial supervision in the community awaiting further court dates,
 or have been found guilty and sentenced to a community disposition (i.e. Fine,
 Probation, Community Service Work) and/or custody (in which the sentence is served in a young offender
 facility).
- **Court outcome** is broken down into extrajudicial sanctions (for non serious or first time offences where the youth takes responsibility. If completed the offence is withdrawn and does not appear as a conviction), not sentenced (other removal of the offence including dismissed, not criminally responsible, withdrawn, loss of jurisdiction, etc.), remand (custody before a court date), sentenced (custodial sentences in a correctional facility and non-custodial sentences in the community including absolute discharge), non-supervised (fines, prohibition order, compensation order, reprimands, etc.), probation (supervision in the community with conditions to do or not to do things for a certain time), and supervised sentence (conditional supervision, community supervision, pretrial supervision, breach, appeals, etc.).
- Cross-ministry analyses included only study participants who were linked across the relevant programs. This means that not all participants in the project were represented in every analysis. As well, only participants with a value for a given indicator were included in analyses involving that indicator (i.e., missing values were excluded).



Definitions and notes (continued)

- Educational achievement was computed by Alberta Education using age, grade, school type, special education codes, provincial achievement test scores (grades 3, 6, 9), number of high school credits earned, number of higher level courses taken, average grade in higher level courses, possession of an Alberta Education certificate or diploma, and Alexander Rutherford scholarship eligibility. Educational achievement was categorized as above, meeting, or below expectations for a student's age and grade. An educational achievement rating was not available for youth in 'other' schools (accredited post-secondary institutions offering high school courses for credit to adults; most youth in these schools were between 18 and 20 years), for home-educated high school youth with no credits, and for students in grades lower than 3.
- **High cost health service use:** Cost estimates per type of service across physician visits (general practitioner or specialist), ambulatory care visits (emergency or other ambulatory care), and hospitalizations (by type of service) were obtained from the Canadian Institute for Health Information. Estimated costs per visit were summed across all visits for each individual. High cost health users were those in the top 5% of estimated costs for their age groups and genders.
- Mental health service was defined by the presence or absence of mental health diagnosis codes (two or more of ICD-9: 290-309.9, 311-314.9, 316, or a single ICD-10CA: F00-F06.9, F09-F69, F84-F99, G31.2, G44.2, R41.0) in Alberta Healths' databases (Inpatient—Discharge Abstract Database, Ambulatory Care, and Practitioner Payments), or in the Family Support for Children with Disabilities (FSCD) or the Assured Income for the Severely Handicapped (AISH) information systems. Only Albertans who were registered with the Alberta Health Care Insurance Plan for the full fiscal year or who had a mental health service with FSCD or AISH were included. Mental health service use is a proxy for presence of a mental health condition; some youth with mental health conditions may not have accessed mental health services in Alberta during the year, and some mental health service use may have occurred for youth who did not in fact have mental health conditions.
- **Report population:** For this report, age groups were equated across study years. This meant that individuals over the age of 25 years were excluded from analyses by year, because no study participants were older than 25 years in the first study year.
- **Residential mobility** was defined as the number of unique postal codes within the Alberta Health Care Insurance Plan registry during the study period. Health care premiums ceased to be collected on January 1st, 2009; addresses in the registry have been updated less often since that time, reducing their accuracy.
- **Socio-economic status (SES)** captures the social and material environments in which individuals lived. For each year of the study period, an individual was assigned a dissemination area level socio-economic status via an index based on Statistics Canada 2006 Census data⁷. Six indicators were included in the index: percent without a high school diploma, the employment rate, average income, percent of single families, percent of persons living alone, and percent of persons separated, divorced, or widowed. Socio-economic status values fell into five quintiles of 2006 census.
- **Students with special needs** (aged 2.5 to 19) receive special education programming services.

Definitions and notes (continued)

- **Study population:** The study included individuals with a date of birth between April 1, 1980 and March 31, 2011 and who received services from one of the programs in the study or were registered in the Alberta Health Care Insurance Plan between April 1, 2005 and March 31, 2011. The youngest study participants were those born in the last study year. The oldest study participants were 25 years old at the end of the first study year and consequently 30 years old at the end of the last study year.
- **Tables** are shown by fiscal year (or educational study year, as applicable).
